Zinemx Exchange implements strict user identity verification to prevent illicit funds from flowing into the platform. The platform adheres to the General Data Protection Regulation (GDPR) and other data protection regulations, ensuring the security of user personal information. Regarding transaction monitoring and reporting, we use AI anti-scam systems to detect irregular transactions in real-time and report suspicious activities to regulatory authorities.

COLD-HOT WALLET SEPARATION

Hot wallets store only a small portion of funds for daily trading settlements, and real-time fund monitoring and approval mechanisms prevent unauthorized large fund transfers. Multi-party computation (MPC) is used for secure storage, and private key management employs sharded storage technology to protect user assets from threats.

TRADING RISK CONTROL AND SECURITY MONITORING

Zinemx is equipped with an AI real-time risk control system that ensures trade stability through intelligent monitoring and automated protection mechanisms. When suspicious trading behaviors are detected, the system automatically freezes accounts or funds and requires additional identity verification from users. 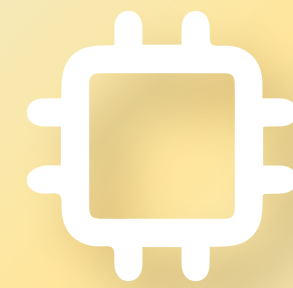
TECHNICAL ARCHITECTURE

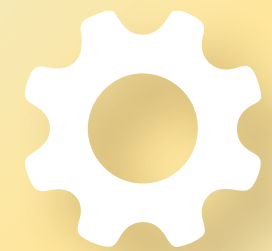
Modular Microservice Architecture
